Tpas, Mal and Jenny, together with local residents from the Community Advisory Groups for Matson and Podsmead, will be working together.

Independent advice is available to all residents of Matson and Podsmead, as well as to families, key workers and carers who support residents.

Residents include, leaseholders, home owners, private tenants and tenants of other housing providers.

Independent Community Advisors and Community Advisory Groups will ensure that all residents in the community are fairly and equally represented and have equal access to information.

Independent Community Advisors will be available and have resources in place to support all households, individuals and families, vulnerable or disadvantaged people, people with

- provide you with independent advice, explaining the facts in a clear, impartial way, supporting you through what can be a very difficult time and process
- help you to become more confident to engage with and help shape regeneration plans.
- feed back on community issues, concerns and comments about the impact of regeneration generally

We don't take sides for or against regeneration- this is not what we are here for – but we will explain all of the options and advise you from an independent perspective on your rights for all options open to you.

We will:

- Agree our priorities for action with the Community Advisory Groups
- Examine and assess information provided by Gloucester City Homes and others to make sure it is accurate
- Hold drop-ins, pop-up sessions and other events to ensure you know what is happening and can ask any questions you might have
- Offer clear, unbiased, accessible and independent information and guidance, including information leaflets, newsletters and a bespoke Tpas web page
- Knock on doors and call into community events to get your views - and ensure you are able to influence the regeneration project either in person or by sharing your views on your behalf
- Meet with individuals or members of their family (at their request)
- Bring together designers, architects, residents groups, Gloucester City Homes and all stakeholders for discussions, to raise awareness and to share information.
- Be there to support you at Gloucester City Homes meetings, consultations events and exhibitions
- Offer group and personal development opportunities.
